Re: UPDATE: Middle Market and Small Business Branch Consolidations

NOTE: The following is an update to correspondence previously sent on June 13, 2003. Included below is an update to the Middle Market office closing chart, policy prefix information that will help you quickly find the appropriate Kemper office and e-mail addresses for our ongoing branches. Please circulate this information widely within your organization.

The information below is limited to changes associated with our Small and Middle Market P&C businesses. Other Kemper business units are not covered by this communication. These units have established their own run-off plan and may still reside in the locations specified below. Additional updates are available under the "Run-Off Contact Information" link located at the top of the Kemperinsurance.com website.

As you are aware, on May 9, the St. Paul purchased the renewal rights to certain small and middle market lines of Kemper business. In conjunction with this transaction, as well as our decision to cease underwriting new and renewal policies, we are in the process of consolidating our field offices to facilitate an orderly runoff of existing policies.

Given the magnitude of the changes underway, we thought it would be helpful to provide you with the following grids that identify transition date, transition leaders, and supporting contact information. This will allow you to continue to secure the support to you may need on routine items such as endorsements, loss run requests etc. You will continue to receive further announcements as future developments dictate. We are also publishing guidelines by line of business for policy changes on our web-site.
